### **Some important information for adult sponsors:**

To ensure that the retreats are both fun, meaningful and safe events for our youth, please make note of the following guidelines (as approved by the presbytery on June 10, 2016) for sponsors:

### **Policy for Volunteers and Paid Staff**

1. As often as practicable, two adults will be assigned to supervise or lead all activities involving children or youth.
2. No person will serve as a teacher or volunteer leader of children or youth activities until an information form is submitted and security background checks have been completed.
3. As often as practicable, all teenage workers or volunteers will be supervised by adults.
4. No fewer than two leaders will be required for all trips and outings.
5. To ensure an adequate level of adult leadership, sponsors for retreats must be at least 21 years of age.
6. To ensure an adequate level of supervision, each group must have one adult sponsor for every six youth. Also each group must have sponsors for both male and female youth, regardless of how many youth in the group. (i.e. if your group has three girls and two boys for the total of five campers, you must have at least two sponsors, one male and one female.) In the event that you do not have the required number of sponsors, it may be possible to combine with another group, as long as arrangements are made before the retreat.
7. Private one-on-one contact between adults and children under the age of 18, and between minors is not permitted. If a personal conference between an adult and child is required, the meeting shall take place in view of other teachers or volunteers.
8. Adult leaders must respect the privacy of youth members in situations such as changing clothes or taking showers on church trips and retreats. Adults should intrude only to the extent that health and safety require. They should also protect their own privacy in similar situations.
9. On trips and presbytery outings adults are not permitted to sleep in the same bed with youth, other than their own child.



10. Appropriate clothing for children, youth and leaders, as determined by the Event Leader, is required for all activities.
11. Discipline used in activities should be constructive and reflect Christian values. Corporal punishment is never permitted.
12. Physical hazing and initiations are prohibited and may not be included as part of any activity.
13. Written parental or guardian permission is required for all overnight outings and trips.

### **Two Adult Rule**

In so much as possible, it is our goal that a minimum of two unrelated adult workers will be in attendance at all times when children are being supervised during our programs, activities and travel to and from events. Some youth classes may have only one adult teacher in attendance during the class session; in these instances, doors to the classroom should remain open and there should be no fewer than three students with the adult teacher. We do not allow minors to be alone with one adult on our premises or in any sponsored activity unless in a counseling situation.

### **Recreational Options:**

#### **Challenge Course**

Challenge course consists of both a low challenge course, as well as a high. The low course is designed to help with team building, and can be beneficial for sports teams, youth groups, or businesses that want to grow closer together as a team. The low course is mostly on the ground, with a few elements getting you a couple feet off the ground. The highs consist of a inclined log, cat walk, two line bridge, rock wall, zip lines, power pole, and a giant swing! This is also great for team building, but also great for overcoming fear and building confidence. With the platform being 38 ft up in the air, you will love the views before going down the 400 ft zip lines.

#### **Paintball**

Newly renovated paintball course will provide you and your group hours of fun. A few vehicles have been added as well as several new bunkers. All participants must be in 1st grade or older, and be big enough for a mask to safely fit on your head.

#### **Bazooka Ball**

This game is quickly becoming a favorite. The barrels on the paint ball guns are replaced to shoot a 2 inch foam ball. This is a great team sport that we can be played both indoor and outdoors.

#### **Arrow Tag**

Not to be confused with shooting bows and arrows, arrow tag uses a special foam tip arrow that allows you to safely shoot each other. Arrow tag can be played both indoors and outdoors.

#### **Ga-Ga Ball & Nine Square**

Ga-Ga ball remains king when it comes to free time recreation.

### Disc Golf

We have a nice little 9-hole, par 3, course that runs around camp. We take advantage of the trees around camp to make it a tough little course, especially in the West Texas wind.

### Outdoor Recreation

In addition to all of the recreation already listed, there is a plethora of other outdoor recreation located throughout camp. A 14,000 sq ft recreation pavilion that houses the 9 square, and multiple basketball hoops. Other activities include washers, horse shoes, corn hole, carpet ball, and multiple recreation fields and various equipment available to rent out such as dodge balls, footballs, basketballs, frisbees, cones, flags, etc.

## AGREEMENT TO ATTEND, PARTICIPATE, ASSUMPTION OF RISK AND RELEASE OF LIABILITY

**CIRCLE SIX BAPTIST CAMP** hereinafter referred to as the "Camp" requires a signature for all attendees of the Camp and all participants of any Camp activity including, but not limited to, Challenge/Ropes Course (highs and lows), Rock Climbing Wall, Swimming Pool, Camping, Basketball, Football, Baseball, Softball, Volleyball, Paintball, Horseshoes, Archery, Archery Tag, Rifle Range, Disc Golf, GaGa Ball, Bazooka Ball and any and all other camp and recreational sports and activities. Furthermore this form releases the Camp to photograph and/or use photographs of myself or my child for use in its publications, advertising, promotional purposes, Internet, and/or visual presentations which inform people of the services and activities of Camp. The signature provided confirms Agreement to Attend, Participate, Assumption of Risk, and Release Form in order to attend Camp and to participate in any Camp activity.

Attendance and Activities at Camp may include warm-ups, games, group initiative problems, high and low challenge course, and/or other rigorous physical adventure activities as well as exposure to the elements, exposure to animals, snakes and insects. Camp takes all reasonable precautions to ensure you a safe and enjoyable experience. Parts of the experience, by their nature, can be physically demanding and include varying levels of stress and anxiety, not all of which can be foreseen. The decision to attend the Camp and the decision to participate in any Camp activity at any level IS AT ALL TIMES COMPLETELY UP TO THE INDIVIDUAL'S CHOICE and, if there is attendance at the Camp and participation at any level of any Camp activity, there is a risk, which must be assumed by each attendee and by each participant. Although it is the Camp's goal to maintain the physical, emotional and social safety of each attendee and participant of the Camp, the physical, emotional and social risks must be assumed by each attendee and participant.

"I understand that attendance at the Camp and participation in any Camp activity may be physically and emotionally demanding. I recognize the inherent risk of physical and/or emotional injury of attending Camp and participating in any and/or all Camp activities. I understand that each participant must assume the risk of any injury, physical and/or emotional, and any financial responsibility that could result from attending Camp and participating in any Camp Activity. I agree to assume such risks and such responsibility. I, on my behalf, and on behalf of my heirs and assigns, hereby release, indemnify and hold harmless Circle Six Baptist Camp from any and all claims, physical and emotional, including bodily injury, that I may have that may be sustained in connection with my attending Camp and with my participation in any and/or all Camp activities."

### CIRCLE SIX POLICIES

3. Drugs, alcohol, any form of tobacco, firearms, knives, or any other kind of weapon, or fireworks are NOT allowed.
4. Appropriate Godly dress attire is expected. Casual clothing is acceptable during all activities. Shorts (for boys and girls), skirts and skorts (for girls) should be no shorter than fingertip length. One piece modest swimsuits are requested. Swimsuits should only be worn at the swimming pool. Shoes are required to and from every activity.
5. Please refrain from Public Display of Affection (PDA) with girlfriends/boyfriends.
6. Please refrain from fighting.
7. All snack items must be stored in sealable containers to prevent ants and other insects in the dorms and meeting rooms. Texas Department of Health regulations prohibit cooking in dorms.
8. Guests are not allowed to bring pets on campus. No pets in the dorms, conference center or meeting rooms.
9. Students are to respect all adult leaders and follow their instructions.
10. ONLY adults should bring a cell phone. We want to ensure attention is placed on the students for safety reasons.
